a) Vessels discharging and loading pay for the second operation again agency fees, reduced by 50%

provided they are handled by the same Agent.

- b) For vessels arriving or sailing or carrying out cargo operations on Sundays or Holidays (daytime)
- extra per case € 300.
- c) For vessels arriving or sailing or carrying out cargo operations on Sundays or Holidays (nighttime)
- extra per case € 400.
- d) In addition to the above fees and surcharges, for arranging the ship's clearance and obtaining sailing

permit €300.

- e) When services mentioned in secton 1 and 2 (below) are rendered in the Piraeus area but outside
- main Piraeus port, St. George's port, or Perama, namely in Salamis , Elefsis, Megara , etc, fees are

increased by 25%.

2. LINER VESSELS

Commissions and / or remuneration for operations effected on liner vessels are subject to agreement between Principals and Agents.

3. PASSENGER AND CRUISE VESSELS

5001 - 10000 € 3850 10001 - 15000 € 4070 15000 and over € 5000

- a) For each passenger embarking or disembarking, the Agents are entitled to an extra fee of € 15.
- b) The Agents are entitled an extra remuneration for each passenger car loaded or unloaded € 35 (motorcycle € 12).

4. VESSELS CALLING

a) For bunkers, stores, minor crew changes, landing of sick seamen etc., and provided stay in port

under 1 (in transit) 50% reduction on fees of section 1.

b) For assisting in delivery or redelivering of vessels for account of Owners or Chart erers or Buyers or

Sellers, and provided this assistance not over 3 days, 50% reduction on fees of section 1, otherwise

full scale to apply.

- c) For repairs and / or conversion and / or dry dock for up to the first 7 days the fees under section 1, for each day thereafter € 200.
- d) For laying up, for the first 7 days as per section 1, thereafter per day € 60.
- e) If any docking and / or repairs are to be executed before or after commercial operations, the Agents

are entitled to the above fees in addition to the other remuneration applicable to the present Tariff.

5. SUPERVISORY AGENCY (PROTECTING AGENTS)

When an Agent is acting on behalf of Owners or Chart erers for vessels consigned to another Agent for loading and /or discharging, the fees under section 1 to apply with a reduction of 50%.

If the Supervisory Agent finds himself under the obligation to pay disbursements accounts for the vessel, the fees under section 1 are applicable in full.

6. GENERAL RULES

a) For the service of supervising discharging and/or loading operations (whether on FIOS or Liner

Terms) the Agents are entitled to a supervisor fee of 5% on the total amount of loading/discharging costs.

b) Embarking or disembarking (crew sign on / off) for group of 1-3 persons € 250. For each additional person of same group € 75.

These amounts do not include any other eventual expenses such as consular fees etc., which will be debited separately at cost.

Visa requisition of crew members each on € 35.

Crew shore pass for each crew member € 10.

c) Before vessel's arrival Owners to place the necessary funds for vessel's expenses at Agent's

disposal. Failing this the Agents are entitled to charge the Owners with a 2% interest per month and

the computation of the time will start from vessel's date of arrival.

- d) When Agents are required to handle matters in connection with the Conferences or with the defence
- of Owners interests in respects of claims against the ship, or with general average or particular
- average with P & I Club representatives.
- e) Any other services not specified in this tariff to be subject to arrangement between Owners and

Agents.

- f) Where agency services are rendered in respect of a ship registered inside the E.U. and responsibility
- for payment is with a Principal within the E.U., the above fees may be subject to negotiations.
